

**Announcement
Fund Amendments**

Manulife Asset Management (Thailand) Company Limited received SEC approval on May 19, 2009 for the amendment of MS-CHINA VALUE, MS-CORE EQ, MS-EQ VALUE, MS-EE EURO, MS-INCOME and MS-GLB RES as follows:

- 1. No selling or accepting client orders to redeem mutual fund units** or stop accepting subscription / redemption orders for funds investing in foreign mutual fund units in cases where the said foreign mutual fund stops accepting subscription / redemption orders. (For MS-CHINA VALUE, MS-EE EURO and MS-GLB RES).

- 2. Termination of fund and the Management Company's arrangements upon termination of fund** : cancel the clause regarding termination of fund in cases where the value of mutual fund units sold (calculated on the basis of the par value) is less than Baht 50 million for 5 consecutive business days; or less than Baht 50 million on any one business day and the Management Company has the intention to dissolve the fund; or less than Baht 30 million on any one business day. (For every mutual fund).

Amendment of the six mutual funds as mentioned is following the Notification of the Office of the Securities and Exchange Commission No. Sorkhor Nor. 32/2551 and does not adversely affect the rights of unitholders.
